Bill Rhatican, the Constitutional Convention and Bill of Rights
Center for the Constitution at Montpelier, home of James Madison

The Center for the Constitution will provide classroom sessions which will focus on U.S. history and the foundations of U.S. government from 1776 to 1814, the Early National Period. Participants will learn about the founding of the U.S. with emphasis on the Bill of Rights, checks and balances, and the importance of the U.S. Constitution. They will also experience how James Madison, father of the U.S. Constitution and President of the United States, lived and gain greater insight on his vision of the founding of the American republic.

The group will participate in a hands-on program called “From Slavery to Citizen” during which they will visit sites on the Montpelier estate with particular connections to the slave and African-American experience at Montpelier and the U.S. in general. Participants will tour Montpelier, learn about George Gilmore and family who were slaves, then freed at the conclusion of the Civil War, visit the home farm that he built after slavery’s end, and see the newly restored Jim

Crow Era Montpelier railroad station. Relief International will pay for Entry fees of participants and Center staff, transportation, and lunch for participants, Center staff and program speakers.

This day's program will put into context all that the participants will experience during the program.

Mr. Rhatican is in his fifth year at Northern Virginia Community College, his first as a full-time professor. He is a former advisor to two presidents of the United States and three United States Cabinet officers (Treasury, Commerce, and Interior). A former consultant to members of Congress, he is now a master teacher for the Bill of Rights Institute. He has written and published numerous articles on personalities prominent in the American Revolutionary War period and has edited three books on American history and the U.S. Constitution.

Deena Hurwitz, University of Virginia School of Law

Professor Hurwitz will lead the group in an interactive presentation and discussion of U.S. and international legal issues, especially those surrounding the Central Asia and the Middle East.

Deena Hurwitz joined the U.VA. Law faculty in 2003 as director of the Human Rights Program and the International Human Rights Law Clinic, having previously been the Robert M. Cover/Allard K. Lowenstein Fellow in International Human Rights with the Orville H. Schell, Jr. Center for International Human Rights at Yale Law School. Hurwitz has worked recently in Afghanistan and Lebanon on clinical legal education, and in Suriname on the rights of indigenous peoples to education and non-discrimination. She also has an interest in the practical aspects of modern Islamic law. Hurwitz's experience includes service as a legal counselor in the Washington office of the UN High Commissioner for Refugees. She spent 1997-99 in Bosnia and Herzegovina, where she was director of Global Rights' (then the International Human Rights Law Group) Bosnia program. She also served as OSCE liaison officer to the Human Rights Coordination Centre of the Office of the High Representative in Bosnia and Herzegovina. Prior to that, she spent time in Ramallah with the Centre for International Human Rights Enforcement as executive administrator for a project involving human rights enforcement under a European Union-Israel trade agreement. She has been a consultant with the Women's Division of Human Rights Watch, investigating violations of women's rights under Morocco's Family Code and spent more than 10 years with the California-based

Resource Center for Nonviolence where she was involved in capacity building and training with nongovernmental organizations in the United States and the Middle East.

Larry Sabato, U.VA. Center for Politics

Participants will gather for this presentation and discussion on contemporary politics and current trends and challenges in U.S. policy and administration.

“Politics is a good thing!” is the slogan of professor Larry J. Sabato, founder and director of the U.VA. Center for Politics. According to the Wall Street Journal, Dr. Sabato is “probably the most quoted college professor in the land.” The author of over 20 books on politics, he has taught more than 14,000 students in his career at Oxford University, Cambridge University, and the University of Virginia. Sabato regularly appears on all of the major television networks to provide political analysis on the issues of the day. He has received every major teaching award at the University of Virginia, and in 2001 he was named the Thomas Jefferson Award winner. At the Center for Politics he brings his years of academic study together with an equally long career as both a political practitioner and commentator on local, state and national elections.

Messrs. Isaacs and Pace will share the VBA Rule of Law Project program as a possible model for the delegates to adapt to their own needs in expanding civic education among young people in Afghanistan. Issues experienced in other emerging democracies will serve as a springboard for facilitating the discussion.

Tim Isaacs serves as Education Coordinator for The Virginia Bar Association Rule of Law Project where he works with educators, legal professionals, and national and international groups to promote the rule of law as the foundation for democratic societies. He has been a teacher and coach, educational supervisor, and Education Policy Analyst. Presentations include the Harvard Institute on Writing, Reading, and Civic Education; the National Curriculum Network Conference on Gifted Education; the Virginia Department of Education; World Justice Forum II; and The National Council for the Social Studies.

Mike Pace is the managing partner of Gentry Locke Rakes & Moore, LLP, based in Roanoke, Virginia. His practice concentrations include commercial real estate development, land use and zoning, business and finance. He was elected President of the

Virginia Bar Association in 2008, served on the Board of Governors from 2004-2009 and is the co-founder and law coordinator of the VBA Rule of Law Project. He is a Trustee of Hampden-Sydney College and served in 2005 as the President of the college's Alumni Association.

Karenne Wood, Virginia Foundation for the Humanities
Virginia Indian Heritage Program

Ms. Wood will discuss widely accepted notions regarding Virginia Indian history and cultures. The participants will examine ways in which Western anthropological theories and language usage have marginalized indigenous peoples and disengaged them from their own past. Ms. Wood will discuss the formation of public opinion: how Americans have come to view American Indians as people of the past and will examine indigenous ideas about collective memory and the

remarkable persistence of indigenous tribal communities who retain their cultural heritage while living in modern society.

Karenne Wood is an enrolled member of the Monacan Indian Nation. She directs the award-winning Virginia Indian Heritage Program at the Virginia Foundation for the Humanities and is a PhD candidate and Ford Fellow in anthropology at the University of Virginia, working to revitalize indigenous languages and cultural practices and to revise American Indian content in educational resources. She has worked at the National Museum of the American Indian as a researcher. Wood held a four-year gubernatorial appointment as Chair of the Virginia Council on Indians. She is the author of Markings on Earth, which won the North American Native Authors Award for Poetry in 2000, and she recently contributed a chapter on Southeastern Indians for National Geographic's reference book, Indian Nations of North America. Last year she spoke at a United Nations' Permanent Forum on Indigenous Issues event on "The Politics of Writing."

She is a graduate of the University of Connecticut and attended the Georgetown University Graduate School of Foreign Service.

J. Harvie Wilkinson, Fourth District Court of Appeals

At the U.S. District Courthouse in Charlottesville, the Honorable J. Harvie Wilkinson will convey the importance of the rule of law to the rights and freedom of Americans. Participants will learn how law can affect and protect the rights of citizens and how that relates to United States democracy.

J. Harvie Wilkinson III was born in New York City and raised in Richmond, VA. After graduating from Yale and serving in the U.S. Army, he entered U.Va. as a law student where he became the first student appointed to the University's Board of Visitors. Following his clerkship for Supreme Court Justice Lewis Powell he returned to U.Va. as

an associate law professor from 1973 to 1978. Six years later he was nominated to the U.S. Court of Appeals for the Fourth Circuit by President Ronald Reagan. Wilkinson has served on the court since 1984 and was its chief judge from 1996 to 2003. In 2004 Judge Wilkinson was also considered as a top candidate to replace Justice Rehnquist as Chief Justice of the U.S. Supreme Court. In 2004, he was honored with the Thomas Jefferson Foundation Medal in Law, the highest external honor bestowed by the University.

Participants will learn about the U.S. judicial system from a sitting state Supreme Court judge.

Justice William Mims was appointed to the Virginia Supreme Court and took his oath of office April 1, 2010 and was formally installed on April 9, 2010. Before becoming a Justice, Mims was elected as the Attorney General of Virginia by the General Assembly in February 2009 to take over for Bob McDonnell. Bill Mims served in the Virginia House of Delegates from 1992-1997, and in the Virginia Senate from 1998 to 2005. He was Chief Deputy Attorney General from January 2006 until February 2009. Mr. Mims has worked as an attorney in Leesburg, Virginia, and served as Chief of Staff to U.S. Rep. Frank Wolf and as Deputy Legislative Director to Senator Paul Trible. He served on the Board of Governors of the Virginia Bar Association from 2002 through 2004, and was a Distinguished Adjunct Professor of Law at George Mason University from 2002 through 2005.

The Honorable Lawrence Eagleburger, Former U.S. Secretary of State
Location: U.Va. Center for Politics

Secretary Eagleburger will lead a discussion on the importance of leadership and being a leader in public service. This session will motivate the participants to see that even though they may face challenges, the leadership they show through their work is of vital importance to the maintenance and success of their nation's governance.

Lawrence S. Eagleburger served as U.S. Secretary of State and White House Chief of Staff during the presidential administration of George H.W. Bush. The majority of his career was spent in the Foreign Service where he served under presidents Reagan, Carter, and Nixon in addition to Bush. Sec. Eagleburger was nominated by President Carter and served as Ambassador to Yugoslavia from 1977 through 1980. He received a number of awards for his government service including in 1992 the Department of State's Distinguished Service Award—the department's highest honor. In 1994, he received an honorary knighthood from Her Majesty, Queen Elizabeth II. Eagleburger was Chairman of the International Commission on Holocaust Era Insurance Claims, a member of U.S. Institute of Peace Iraq Study Group, and Chairman of the Board of The Forum for International Policy.

Attorney General Cuccinelli will discuss the role of the Attorney General's Office in state government at his office in Richmond.

Ken Cuccinelli was elected Attorney General of Virginia and sworn into office on January 16, 2010. As Attorney General, he is responsible for overseeing an office of more than 300 attorneys and staff. Prior to serving as Attorney General, he served in the Senate of Virginia from August 2002 to January 2010. Attorney General Cuccinelli earned a degree in mechanical engineering from University of Virginia, a master's degree in International Commerce and Policy from George Mason University, and his juris doctor from George Mason University School of Law and Economics.

Local Government and the Importance of Public Service
Dave Norris, Mayor of Charlottesville

Mayor Norris will meet with the delegation in the Charlottesville City Council chambers and discuss how the local Charlottesville government functions and the importance of public service.

Before Dave Norris was elected Mayor in 2008 he was voted onto City Council in May 2006 on a platform that focused on four key issues: creating affordable housing for renters and homebuyers, enhancing educational opportunities for children and adults, fighting poverty and reducing racial disparities in our community, and promoting environmental sustainability in local and regional planning. Dave currently works as Executive Director of Big Brothers Big Sisters of the Central Blue Ridge, which helps area children realize their highest potential through one-on-one mentoring relationships. In previous positions, he's served as Executive Director of PACEM, Associate Director of Madison House, Interim Director of PHAR (the Public Housing Association of Residents), as founding Director of the Connecting People to Jobs Initiative (a joint venture between PHAR and Piedmont Virginia Community College), and as Coordinator of the Virginia Economic Development Corporation's Micro Loan Program for low-income, minority and female entrepreneurs.

The delegation will attend a Charlottesville City Council Meeting to experience firsthand how the local government in Charlottesville operates.

City Council makes policy in the areas of city planning and finances, human development, public safety and justice, public utilities, and transportation. It has specific powers to pass ordinances, levy taxes, collect revenues, adopt a budget, make appropriations, issue bonds, borrow money,

and provide for the payment of public debts. Regular meetings of the council are held the first and third Mondays each month at 7:00 p.m. in council chambers (in City Hall on the Downtown Mall at 7th and East Main Streets). Meetings are open to the public and time is available for speakers on subjects not scheduled for a public hearing at the beginning and end of each regular meeting.

The presentation will offer examples of the work done by the Mortimer Caplin Public Service Center in the local community, and will offer an opportunity to discuss ways in which the participants could implement similar action once they return home.

Yared Getachew is assistant dean for public service and director of the Mortimer Caplin Public Service Center at the School of Law. He graduated from the University of Virginia in 1994 with a BA in foreign affairs and a minor in French language and literature. He earned his law degree at the University of Virginia in 1998, where he served on the Virginia Environmental Law Journal. Before he returned to the Law School in the fall of 2006, his legal experience included work as a judicial law clerk in Delaware and Philadelphia, a prosecutor in New Jersey, and a legal adviser on international humanitarian affairs in Washington, DC, and in Addis Ababa, Ethiopia. He has extensive courtroom experience in criminal and immigration courts, and has also appeared before an international claims tribunal in The Hague, Netherlands.

Michael Cornfield runs a consulting practice specializing in campaign communications research, training, and content creation.
